 - The 2MP Starlight HDCVI Box camera shall offer an HDCVI and a CVBS output each with a BNC connector.
 - 4. The 2MP HDCVI Dome camera shall transmit 2MP video up to 800 m (0.49 miles) via RG6 coaxial cable, and up to 300 m (0.19 miles) via CAT5e UTP cable. Actual transmission distance may vary due to the quality and deployment of the cable.

B. Imaging

- 3. The 2MP Starlight HDCVI Box camera shall offer a 16:9 aspect ratio.

- The 2MP Starlight HDCVI Box camera shall transmit video and data via a coaxial cable, or via UTP using balun, and shall accept power from power adapter or via coaxial cable using external POC modules.
- The 2MP Starlight HDCVI Box camera shall support the following dual power options:
 - a. 12V DC source ±25%
 - b. 24V AC source ±25%

E. Housing Options
